Sir / Madam,

NIEPMD-NBER is going to conduct Practical Examinations –August 2018 for ACCIE (CD), DPO, CPO, CRT & DRT course from 4th to 17th August 2018. In this regard all the course coordinators of concerned institutions are requested to follow the following guidelines:-

1. The Practical Examiner will be appointed by NIEPMD-NBER directly and the institute will be informed about external examiner before 3 days from commencement of the exam dates. The change of the External Examiner, if needed, is **sole responsibility** of the NIEPMD-NBER.
2. All the course coordinators are requested to send the exam dates (between 4th August to 17th August 2018 except Independence day) to NBER in your letter head with sign and seal of the institute and the copy of this letter send to our Email i.e niepmd.examinations@gmail.com
3. You are hereby requested to send **the internal theory and practical marks** in the prescribed format. The format is available in the NBER website. The internal marks hard copy should reach at NBER on or before **14th August 2018**.
4. The External Marks should send by the **External Examiners** immediately after the completion of practical examinations.
5. The external practical marks should reach at NIEPMD-NBER office within 3 days after the examination got over.
6. **Remuneration of External Examiner:**
The Institute has to pay the examination expenses of external examiner on the basis of NIEPMD NBER remuneration guidelines and it will be reimbursed to the institutes only when the **original bills** submit to NIEPMD-NBER.
7. The details of practical examination will not be changed after it is approved by NBER.
8. The External examiner cannot be changed at any circumstances once he / she is appointed.
9. **Percentage of attendance:** Kindly note that if any candidate has less percentages of attendance in the practical subjects, that candidate is not eligible for attending the practical examination as mentioned in **Circular 17/23**. If any candidate attend the practical Examination without enough percentage of attendance, the candidate result will be withheld.
10. The practical examination will not be allowed to conduct after the theory examination.
