It has been observed that after declaration of Diploma results, many of the Institutions have been requesting NIEPMD-NBER for amendments in the internal marks awarded by them in both theory and practical examination. All the Course Coordinators are requested to verify the marks entered in the prescribed format, before forwarding the hardcopy and while submission of marks through online to NIEPMD-NBER. This has been viewed seriously.

As a onetime measure, to rectify the errors occurred during this academic year 2017-18, before printing the Statement of Marks of the students, NIEPMD-NBER has decided to impose penalty on such institutions where the typographical errors has been occurred in the hardcopy and softcopy of the internal and external theory and practical marks. The institutions who have requested for such amendments warned severely and such incidents should not occur in future.
